## 02. FOODTECH INNOVATION AWARDS 2024 CATEGORIES

The proposals that will be considered to participate in the Awards must be in the framework of the following categories:

1. The most innovative solution on digitalization Award for the food and beverage industry
2. Best Sustainability Project
3. Healthy Food
4. The Best Automation and Robotics solution for the food value chain
5. The best innovation Project for the Packaging industry
6. The most innovative Startup
7. Spanish startup with the greatest international projection

### 1. The most innovative solution on digitalization Award for the food and beverage industry award

This category seeks to recognise the work and effort of the company, platform, solution or technological application that is impacting and transforming the food and beverage industry, its sales model, its production, process, contact with the consumer or value proposition through a solution linked to the digital and technological sphere. Applications of technologies such as IoT, cloud, Artificial Intelligence, Digital Twin or biotechnology among others to the food and beverages industry will be considered.

### 2. Best sustainability project award

The aim is to recognise the work and effort of positive impact as an alternative to a problem of environmental impact; and as a fulfilment of the sustainable development goals. SDGS. Such as packaging waste, actions to reduce climate change, more sustainable agricultural practices, science and research applied to understanding and improving environmental impact, circular economy, and better sustainability awareness initiatives.

### 3. Healthy food award

The aim is to recognise the work and effort of the company, project or platform that promotes an innovative and/or scientific solution that promotes healthy eating. This award contributes to the promotion of innovative projects developed throughout the value chain of the food industry, as well as projects within the framework of Foodtech whose solution has a direct impact on healthy eating.

### 4. The best automation and robotics solution for the food value chain award

This category is focused on the use of automation and robotics to boost the competitiveness of their production processes or their factories. ## 09. EVALUATION PROCESS

The evaluation process is divided in two phases:

### PHASE 1:

Regulation compliance and pre-selection: The Evaluation Committee will conduct the first evaluation to check whether the entries comply with the requirements and conditions defined selection criteria.

A pre-selection of 3 pre-award candidates per category will be made. Pre-selected candidates will be informed by email.

The organiser will then be able to request additional information if needed in order to complete the information submitted in the entry.

Proposals may exceptionally be subject to a change of category according to the observations of the Evaluation Committee. The candidate will be informed in due time.

### PHASE 2:

Winners selection: The Evaluation Committee will assess the projects, selecting each Food 4 Future 2024 award category winner.

The Evaluation Committee members and the winners will be announced during the Food 4 Future Ceremony to be held on **April 17th** in a location to be selected by the Organiser.

Pre-selected Awards finalists candidates will be notified from **March 25th 2024** onwards to the main email address specified in the registration form.

The Steering Committee decision is final and private and not subject to any queries or public Investigations.

Any of the Food 4 Future 2024 Awards categories may be declared void by the Evaluation Committee.
